

# VATICA PRIVACY POLICY

This privacy policy describes how Vatica Health, Inc. ## Information We Collect

- Unique identifiers such as internet protocol (IP) address, browser type, computer or mobile device, your navigation and clickstream behavior from actions you take on our Website.

## How We Collect Your Information

We also use "cookies" (small files placed on your hard drive) on certain of our pages to help analyze our web page flow and customize our services or content. You are free to decline our cookies if your browser permits, although doing so may interfere with your use of some of our Website. This technology is not intended to identify you to us in any way.

## How We Use and Disclose Your Information

We will not sell, rent or license your personal information obtained on our Website without your consent. We may use and disclose your information for the following purposes:

- To operate, maintain and improve our Website
- To facilitate and improve your experience on our Website
- To market our new products, services or events
- Related to a merger, acquisition or sale of all or a portion of our assets
